



## CITY OF OPA-LOCKA NOTICE OF COMMUNITY REDEVELOPMENT AGENCY MEETING

**NOTICE IS HEREBY GIVEN** that a meeting of the Opa-locka Community Redevelopment Agency Meeting will be held on **Tuesday, January 11, 2022, at 5:30 p.m.**, in the auditorium at Sherbondy Village, 215 Perviz Avenue, Opa-locka, Florida. The purpose of this Community Redevelopment Agency Meeting is to discuss and consider the following:

- A) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA), AMENDING THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY'S ANNUAL ADOPTED GENERAL OPERATING AND TAX INCREMENT FUND BUDGET FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2021, AND ENDING SEPTEMBER 30, 2022, AS SET FORTH IN EXHIBIT "A"; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**
- B) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA) AUTHORIZING ALLOCATION AND PAYMENT OF SIXTY-THOUSAND DOLLARS (\$60,000.00) TO THE CITY OF OPA-LOCKA'S PARKS FENCING PROJECT, FOR THE CONSTRUCTION OF FENCING AROUND SHERBONDY PARK, INGRAM PARK AND MAGNOLIA PARK WITHIN THE OCRA REDEVELOPMENT AREA; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**
- C) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA) AUTHORIZING THE HIRING OF AN ADMINISTRATIVE ASSISTANT AND INTERN AS SUPPORT STAFF FOR THE OCRA; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**
