NOTICE OF COMMUNITY REDEVELOPMENT AGENCY MEETING**

NOTICE IS HEREBY GIVEN that a meeting of the Opa-locka Community Redevelopment Agency Meeting will be held on **Tuesday, July 26, 2022, at 5:30 p.m.**, in the auditorium at Sherbondy Village, 215 Perviz Avenue, Opa-locka, Florida. The purpose of this Community Redevelopment Agency Meeting is to discuss and consider the following:

- 1.) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA) ESTABLISHING A RENTAL ASSISTANCE PROGRAM WITH AN ALLOCATION OF ONE HUNDRED THOUSAND DOLLARS (\$100,000); PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**
- 2.) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA) ESTABLISHING A MORTGAGE ASSISTANCE PROGRAM WITH AN ALLOCATION OF ONE HUNDRED THOUSAND DOLLARS (\$100,000); PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**
- 3.) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA) ESTABLISHING A PROPERTY AND BUSINESS IMPROVEMENT PROGRAM WITH AN ALLOCATION OF TWO HUNDRED AND FORTY-FIVE (\$245,000.00) DOLLARS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**
- 4.) A RESOLUTION OF THE OPA-LOCKA COMMUNITY REDEVELOPMENT AGENCY (OCRA) DIRECTING THE INTERIM CRA MANAGER TO ALLOCATE PAYMENT OF TEN PERCENT (10%) OF ALL SALARIES OF THE CITY OF OPA-LOCKA'S PLANNING AND COMMUNITY DEVELOPMENT STAFF FOR FISCAL YEARS 2019-2020 AND 2020-2021; PROVIDING FOR AN EFFECTIVE DATE.**
