AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF OPA-LOCKA, FLORIDA, AMENDING ARTICLE XI, DIVISION 5, SECTION 2-530 OF THE CITY OF OPA-LOCKA'S CODE OF ORDINANCES ENTITLED "POWERS OF HUMAN RESOURCES DIRECTOR" TO SPECIFICALLY ADD NEW PARAGRAPH 11 TO PROVIDE THAT THE HUMAN RESOURCES DIRECTOR MAY BE CONSIDERED AN OUTSIDE ENTITY FIRM OR PROFESSIONAL CONTRACTED BY THE CITY COMMISSION TO PERFORM THE DUTIES AND RESPONSIBILITIES OF A HUMAN RESOURCES DEPARTMENT, AS SET FORTH WITHIN THE CITY OF OPA-LOCKA'S CHARTER, CODE OF ORDINANCES OR AS OTHERWISE DETERMINED APPROPRIATE BY THE CITY COMMISSION; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT AND REPEALER; PROVIDING FOR SCRIVENER'S ERRORS; PROVIDING FOR AN EFFECTIVE DATE.
