



# CITY OF OPA-LOCKA BEAUTIFICATION PLAN




## VISION STATEMENT:



## **ZONES 1-7**




## IMPLEMENTATION RECOMMENDATIONS:

To kick-start the City Beautification effort, installing the Gateway, Wayfinding, and Street signage would be an effective, relatively easy, and inexpensive effort for the City. In addition to a signage plan, the following is a list of recommendations to consider for implementing the Beautification Plan:

1. Develop City gateway, wayfinding, and street name signage plan for fabrication and installation of the signage. This can be done in phases to follow the city's budget.
2. Identify upcoming City projects such as road and streetscape improvements, park, and/or trail projects. Identify beautification elements that could be incorporated into these projects.
3. Identify additional funding opportunities such as Economic Development grants to assist in the implementation effort of the Beautification Plan.



## COMMUNITY INVOLVEMENT:

- Six City-led community clean-up events annually to generate interest, enthusiasm, and pride.
- Conduct events at City parks to attract residents to encourage them to take pride in the appearance of their parks and streets for residential and commercial properties.
- Encourage community groups and organizations to adopt parks and roadways to establish a culture of pride and caring for the appearance of the city.
- Develop a street beautification contest by zones specifically for the residential zones and award the best street with a recognition.
- Create a space on the website and feature residential houses or communities that are taken care of meticulously.
- Create a Recycle Program with business, residents, schools, and faith-based organizations with the support and involvement of other municipalities.
- Annual event to provide residents the opportunity to dispose of contaminants such as paint, oils, and other items at no cost; this can be done with the support of Miami-Dade County or any other entity.



## **BEAUTIFICATION GUIDELINES – THINGS TO DO**

- KEEP YOUR PROPERTY AND ALL ACCESSORY STRUCTURES SUBSTANTIALLY FREE OF DIRT, STAINS, RUST, MOLD, MILDEW, AND VISIBLE DAMAGE. ACCESSORY STRUCTURES INCLUDE FENCES, ROOFS, SHEDS, POOLS, ETC. Pursuant to the city's Code Section 14-2.
- MOW THE LAWN ON YOUR PROPERTY AND THE SURROUNDING PUBLIC RIGHT-OF-WAY TO AN AESTHETICALLY PLEASING HEIGHT. THIS HEIGHT SHOULD NOT EXCEED 8 INCHES TO AVOID CITATIONS. THE PUBLIC RIGHT-OF-WAY SURROUNDING YOUR PROPERTY COULD INCLUDE SWALE AREAS AND ALLEYWAYS. Pursuant to the city's Code Section 14-2.
- THE ROOF OF YOUR PROPERTY MUST BE STRUCTURALLY SOUND, CLEAN, AND MAINTAINED.
- KEEP PAINT FRESH AND CLEAN ENSURE YOUR PROPERTY AND THE SURROUNDING PUBLIC RIGHT-OF-WAY IS FREE OF TRASH, LITTER, AND DEBRIS.
- PROPERTY OWNERS ARE RESPONSIBLE FOR TRIMMING ALL OVERHANGING TREES AND/OR SHRUBS OBSTRUCTING THE PUBLIC RIGHT-OF-WAY.
- PLACE ALL TRASH, LEAVES, GRASS CLIPPINGS, SHRUBBERY CUTTINGS IN 32-GALLON CONTAINERS.
- REMOVE EMPTY CONTAINERS FROM DRIVEWAY/YARD AFTER THE COLLECTION FOR THE DAY AND PLACE EMPTY CONTAINERS OUT OF SIGHT.
- WRAP BROKEN GLASS, OLD RAZOR BLADES, OR TIN CAN LIDS IN THICK PAPER TO BE DISCARDED.
- OBSERVE THE CITY'S NUISANCE ORDINANCES AND BE CONSIDERATE OF YOUR NEIGHBORS. AVOID LOUD MUSIC AS THE CITY'S CODE MANDATES NOISE TO STOP FROM 11:00 P.M. UNTIL 7:00 A.M. NOISE SHOULD BE WITHIN ACCEPTABLE LEVELS DURING ALLOWED HOURS OF THE ORDINANCE.
- DISPOSE OF LIQUIDS DOWN THE DRAIN SYSTEM IN YOUR HOME BEFORE PLACING THEM IN YOUR GARBAGE.
- WALK YOUR DOG WITH A LEASE. Pursuant to the city's Code Section 5-51.
- KEEP YOUR PROPERTY CLEAN OF DEBRIS AND TRASH. Pursuant to the city's Code Section 11-1.
- PLACE YOUR GARBAGE CONTAINERS IN THE RIGHT PLACE. Pursuant to the city's Code Section 11-17.
- MAKE SURE PROPERTY ADDRESS IS VISIBLE DISPLAYED FOR SAFETY AND EMERGENCY PURPOSES.

## **BEAUTIFICATION GUIDELINES – THINGS NOT TO DO**

- DO NOT MIX GARBAGE (FOOD REMAINS, FOOD CONTAINERS OR WRAPPINGS, OR FRUIT WITH TRASH).
- DO NOT PLACE TRASH ON THE PARKWAY/DRIVEWAY EARLIER THAN THE DAY BEFORE OR THE DAY OF YOUR NORMAL GARBAGE PICKUP.
- DO NOT LEAVE GARBAGE UNCOVERED.
- DO NOT STORE JUNK, LITTER, AND/OR GARBAGE ON YOUR PROPERTY.
- DO NOT BLOCK ENTRANCES TO PRIVATE PROPERTIES.
- DO NOT PARK ON THE CITY'S SIDEWALK, MEDIAN, OR SWALE TO AVOID RECEIVING A CITATION FROM THE POLICE DEPARTMENT.
- REMEMBER IT IS UNLAWFUL FOR ANY PERSON TO POSSESS, BREED, OR MAINTAIN DOMESTIC FOWL OR LIVESTOCK ON OR ABOUT ANY RESIDENTIAL PREMISES WITH THE CITY.
- DO NOT STORE DAMAGED VEHICLES ON YOUR PROPERTY WITHOUT A VALID TAG.
- DO NOT PAINT YOUR HOME OR BUSINESS WITHOUT SECURING A PERMIT.
- DO NOT INSTALL FENCING WITHOUT SECURING A PERMIT.
- DO NOT REMOVE/INSTALL A ROOF WITHOUT SECURING A PERMIT.
- DO NOT INSTALL A DRIVEWAY WITHOUT SECURING A PERMIT.

When pet waste is left on sidewalks and lawns, it is carried into nearby canals, lakes, and streams when it rains which causes pollution to the water and creates a health hazard. Whether you live in a house or an apartment, picking up after your pet is part of being a good neighbor and responsible pet owner.

- When walking your pet, take a bag with you.
- Keep a supply of bags near your dog leash, near the front door, or in your vehicle.
- When at home, long-handled “pooper scoopers”, available at pet stores, make it easy to pick up after pets without bending.

## WHAT IS STORMWATER POLLUTION?

Stormwater pollution happens when the water picks up pollutants such as car oil, dog waste, excess fertilizer, herbicides, and pesticides on lawns, cigarette butts, and other trash. These pollutants go down the nearest catch basin and end in our lakes, rivers, and streams.

In addition to polluting the water, stormwater can cause flooding, sewage backups, and erosion. As more and more open space land is developed and covered by impervious surfaces (surfaces where water cannot penetrate), stormwater cannot infiltrate into the ground and is forced to become runoff.

## SO, WHAT EXACTLY IS POLLUTING?

### TRASH

Keep leaves, trash, animal waste, and pesticides out of our sidewalks, lawns, and streets. You might be wondering how this cause water pollution? During a storm, rain can carry all of these off your lawn into the nearest storm drain where they flow --- untreated --- into your nearest canal or stream. As you can imagine the chemicals in pesticides, and the waste from your pets are not good for the plants, fish, or wildlife in our water bodies, and they are not good for boaters or swimmers, either. While the leaves, grass clippings will decompose and release Phosphorus into the water, causing fish kills and algae blooms that are toxic to humans and wildlife alike.





## Residential Solid Waste



As a customer, you will enjoy a variety of waste collection services including an automated curbside garbage collection service, curbside bulky waste collection and access to the Neighborhood Trash and Recycling Centers. Please be sure your green waste cart is placed on the curbside no later than 7 a.m. on your collection day.

### Opa-locka Customer Fact Sheet (PDF)

City of Opa-locka residents is reminded that the Department of Solid Waste Management (DSWM) offers a variety of waste collection services for its customers. The following tips will be useful as you familiarize yourself with your services. Following these tips will ensure that service is provided without interruption and in a timely fashion:

#### **Residential Curbside Garbage Collection**

- Carts must be placed at the curb by 7 a.m. on your service days. When service is complete, remove your cart from the right-of-way and return it to its storage place.
- All waste must fit inside the green waste cart, and the lid must be closed completely. Do not place additional bags or loose items alongside the cart. They will not be collected.

- The green waste carts cannot be used for disposal of rocks, dirt, sand, tile, construction and demolition debris, free-flowing liquids, flammables, automobile batteries, propane tanks or other home chemical waste.

### **Bulky Waste Pickup**

- Be sure to schedule a bulky waste pickup prior to placing items at the curb. You can schedule a pickup by calling 311 or by visiting <http://www.miamidade.gov/311direct>.
- Automobile tires cannot be placed at the curb as part of a bulky waste pickup. You may deliver up to four standard-size automobile tires per visit to a Trash and Recycling Center.
- Remove doors from refrigerators and freezers. This is an important safety precaution.

- Mattresses placed at the curb for a bulky waste pickup must be fully encased in a plastic bag or sleeve.
- Construction and demolition debris (such as steel, concrete, glass, brick, asphalt, roofing material, lumber, drywall and tile) is limited to one cubic yard or less (a pile slightly larger than a washing machine) [see Image 1].


#### **Trash and Recycling Centers (TRC)**

- DSWM residential customers who visit a TRC must present a valid driver's license to use the facility.
- Garbage (food and kitchen waste) cannot be disposed of at a TRC.
- Construction and demolition debris (such as steel, concrete, glass, brick, asphalt, roofing material, lumber, drywall, and tile) is limited to one cubic yard or less (a pile slightly larger than a washing machine) [see Image 1].
- Customers who bring more than one cubic yard of construction and demolition debris to a TRC will be turned away.
- Items that cannot be accepted at a TRC must be properly disposed of at one of the DSWM's paid disposal facilities or at a commercial disposal facility.
