



## **CITY OF OPA-LOCKA, FLORIDA NOTICE TO THE PUBLIC**

**NOTICE IS HEREBY GIVEN** that the City Commission of the City of Opa-locka, Florida, will hold public hearings at its Regular Commission Meeting on **Wednesday, January 14, 2026, at 6:00 p.m.** at the Opa-locka Government Center, 780 Fisherman Street, 3rd Floor, Opa-locka, Florida, to consider the following items for final adoption:

### **SECOND READING ORDINANCES / PUBLIC HEARINGS:**

**AN ORDINANCE OF THE CITY OF OPA-LOCKA, FLORIDA, AMENDING ARTICLE IV ENTITLED “PURCHASING” OF THE CITY’S CODE OF ORDINANCES; AMENDING SECTION 2-361 RELATING TO “PUBLIC PRIVATE PARTNERSHIP; SPECIFICALLY AMENDING SUBSECTION (D)(2) ENTITLED “UNSOLICITED DETAILED ROPOSALS” TO REDUCE THE PROPOSAL REVIEW FEE FROM \$50,000.00 TO \$25,000.00; PROVIDE THAT IN THE CASE WHERE A PRIVATE ENTITY HAS ALREADY PAID FOR REVIEW OF A SUBSTANTIALLY SIMILAR CONCEPTUAL PROPOSAL, REDUCING THE FEE FOR REVIEW FROM \$45,000.00 TO \$20,000.00; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING FOR AN EFFECTIVE DATE (first reading / public hearing held on December 10, 2025).**
